

IMPORTANT PRESCRIBING INFORMATION

Subject: EBANGA™ (ansuvimab-zykl) Storage/Use and Lot-Specific Information Available via www.EBANGA.com

Dear Health Care Provider:

The purpose of this letter is to inform you of important information regarding the expiry period for EBANGA™ (ansuvimab-zykl), an anti-*Zaire ebolavirus* glycoprotein (EBOV GP) human monoclonal antibody, indicated in adult and pediatric patients, including neonates born to a mother who is RT-PCR positive for *Zaire ebolavirus* infection.

Storage and Use

EBANGA product vials are stored within the respective 36-vial Carton to PROTECT FROM LIGHT. The storage temperature is 2–8°C (36–46°F).

Dilute the EBANGA solution immediately upon reconstitution. If needed, the reconstituted solution may be stored refrigerated at 2°C to 8°C (36°F to 46°F), protected from light, for up to 4 hours. This 4-hour window includes time required for further dilution and EBANGA solution should be infused immediately upon further dilution. Please see the Full Prescribing Information for more details.

Lot-Specific Expiry Information and Product-Specific Website

EBANGA lot numbers are printed on the vial label, on the back side of the 36-vial carton and on the tertiary boxes.

To provide for extension of the expiry period as well as to satisfy required reporting obligations to the Food and Drug Administration (i.e., product tracing and tracking), lot-specific EBANGA information is available via: www.EBANGA.com. This website is listed on the vial label, on the back side of the 36-vial carton and in the Package Insert.¹

The website requires first-time users to register using Multi-Factor Authentication. The secure-access website provides EBANGA expiry dating information in a lot-specific format. Scanning the Quick Response (QR) Code with a mobile phone will take you to the EBANGA website (www.EBANGA.com).
